Just as a reminder, Constitution and Bylaws must be rewritten every ten (10) years. Please remember to use the “Model Bylaws” for both Unit and District that are on the Department Website (www.calegionaux.org). They are “fill in” copies so they will be easier for both the Unit/District Constitution and Bylaws Chairman’s to complete. Please remember that your Unit and District Bylaws must be in accordance with the Department Constitution and Bylaws; i.e. Your officers must be the same. You may add officers such as Marshal or Webmaster, but may **NOT** delete any officers such as 2nd Vice President, Historian, Executive Committee Woman etc. Remember that there must be 2 complete copies and 5 signature pages when complete. (Remember to keep a copy for yourself before sending). These will then be sent to this Chairman for approval, then forwarded onto the Department President for her signature. After which, when all signatures are received, 3 copies will be returned to you. One each is to be attached to the set of the Constitution and Bylaws for the Unit, District and one to the District President. Please remember that on the Signature Page it requests the dates of the TWO separate readings of the Constitution and Bylaws. These must be TWO separate meeting dates, this is very important. Please be sure that both the Constitution and Bylaws Chairman and your President sign, it will

only delay Department approval if they must be returned for the signatures. All rewrites must be submitted 45 days prior to the Department Convention to be seated at convention.
